- (iii) Arranged for two clear ups of GAP and minor repairs, and the removal of the summer bedding and some winter planting.

- (iv) Reported damage to a tree on footpath 7 following three attempts by Mr Ryman to make it as safe as possible but it requires DCC to action.
- (v) Informed DCC of co-option and submitted the Register of Interest form.
