Public Participation

6.1 St Peter's substation graffiti

Cllr Platten referred to the graffiti on the transformer/substation at St Peters. The owners should be told to remove it.

6.2 High Row steps/footpaths

The steps were reported as in need of cleaning and that a couple of stones were loose.

Action – Arrange cleaning/repair.

It was also a concern that the footpath down to Low Green can often have vehicles parked across it (Low Green exit). This presents as a problem for those with a buggy, or those with reduced mobility.

Action: To be looked at ways to alleviate the problem to prevent vehicles parking across the footpath exit.

6.3 Recreation Field boundary -East by School Lane

Damage to the boundary fence/hedge was reported (East side School Lane) giving free access to the field for dogs/rabbits.

Action – Contact local contractor to quote for repairs.

Purpose

Scope

The following are some of the opportunities where the brand styling could be used:

- Village signage e.g. recreation field, GAP playground
